 - Shirley is continuing to work with Paul Sizer on graphics needed for the 2025 - 2026 Season.
 - Shirley is continuing to work with Joan VanSickler on updates for the website.
 - Mike G. and Shirley will be meeting with Neil Jansen at Chenery Auditorium to talk about our needs for our upcoming season.
 - The Donor Letter will be going out in August about our Holiday Concert.
 - Holiday Parade and Kindelberger contracts are in.
6. Finance Committee (Mike Grear):
 - Donor and Sponsorship opportunities have been created and will begin for the 2025 - 2026 season.
 - Mike G. shared the updated Donation Opportunities and Benefits Sheet. Susan Carter made a motion to approve the different tiers and their descriptions. Josiah Solis seconded the motion. The motion carried.
 - Susan Carter suggested that Ken Mohney be in charge of the Sponsorship Program. Laurajane agreed to talk to Ken about it.
 - Josiah will create a flyer advertising the Sponsorship Program
 - Larry Ellis suggested having directions for the KCB Board and KCB Members on how to promote the Sponsorship Program..
7. ProMotion Committee (Susan Carter):
 - Susan Carter talked to Doug and we can share our music on the website because it is our website which means we are not violating any copyright laws..
 - Joan VanSickler presented our new demo website. In addition to the demo site, it was also shared that there has been a Mobile/Tablet upgrade as well. The total cost for the upgraded KCB Website and Mobile/Tablet upgrade is \$1868 (\$52 per hour). This is the non-profit rate. Mike M. made a motion that

we approve the cost of \$1868 in order to move forward with the KCB Website and Mobile/Tablet updates. Larry Ellis seconded the motion. The motion carried.
